

# **Delegate's Message**

Greetings,

When you read this Bulletin, our Officers, Coordinators and Liaisons will have attended the January meeting in Nanaimo. I, your Delegate, who is double vaccinated and had the booster shot, plan to attend in person.

At this meeting we will plan for the upcoming Area World Service Committee meeting to be held in May, which plans to be exciting and hopefully in person.

My role as your delegate, got off to a high volume start with emails pouring in. I am sorting through them and getting a plan together for the Conference to be held in New York this April.

The new World Service Conference members met January 8<sup>th</sup>, with an online meeting to learn procedures, purpose, and composition for the upcoming World Service Conference. We also reviewed Knowledge-Based Decision-Making (KBDM), which Al-Anon uses in our meetings, both at your group level and all levels of Al-Anon. You may see it in action at Area World Service Committee meeting or at Assembly this September.

# Five Key Elements to Knowledge Base Decision Making

- 1. Open communication between leadership and membership
- 2. Dialogue before deliberation
- 3. Common access to full information for all decision-makers
- 4. Existence in a culture of trust
- 5. Confidence in the competency of our partners

### Knowledge Base Decision Making (KBDM) Questions

<u>Question 1</u>: What do we know about our members' or prospective members' wants, needs, or preferences that are relevant to this discussion? What do we wish we knew, but don't?

Question 2: What do we know about the capacity and strategic position of the organization relative to this issue? What do we wish we knew, but don't?

Question 3: What do we know about the current realities and evolving dynamics that are relevant to this discussion? What do we wish we knew, but don't?

<u>Question 4</u>: What are the ethical implications of our choices (pros and cons)? This includes consideration of how the Legacies apply. Identify both Pros and Cons. What do we wish we knew, but don't?

I have also been thinking about our traditions, mostly our Tradition 4. "Each Group should be autonomous, except in matters affecting another group or Al-Anon or AA as a whole." As I hear this tradition, I often seem to hear members saying the first few words up to the comma, thinking we are autonomous and we can do as we like, but the tradition says after the comma "except" and that is where some of us get lost. The tradition teaches us that it is important to consider the greater good of Al-Anon or AA.

In my recovery, I have read the Service Manual and studied the Traditions. As 2022 is underway, I would like to invite all members and groups to read and study our Service Manual, as we move into our future.

# **Alternate Delegate**

Hello Everyone,

I am looking forward to the privilege of attending the Officers and Coordinators Meeting as your Alternate Delegate scheduled for late January.

By the time you read this report it will have already happened; with some members attending live, and others by hybrid. It will be a chance to meet all the existing Officers and Coordinators along with new incoming service members, like myself starting their journey in a new Area service position.

The wonderful thing is the way we have structured our area rotation of service. The Officers are elected and the Coordinators positions are appointed in a rotating schedule of election and appointments that is staggered over 3 years. That works well for continuity of service as service members are not all incoming or outgoing at the same time. The background discussions and decisions can be passed on by members who were present in past discussions or events, to the newer members to continue.

As Alternate Delegate I have already participated in a Thought Force (description of a Thought Force page 71 Service Manual); with members in a variety of service positions in the BC/YUKON Area.

Our focus is to produce some recommendations and answers moving forward for electronic meetings in the BC/Yukon Area. The process has really had me dig deep into our Al-Anon books to find answers in our three legacies - the Steps, Traditions and Concepts. As well, we used the Knowledge Based Decision Making (KBDM) process and created different perspectives from each individual member. We have gathered the background information and compiled a report that was presented to the Officers and Coordinators at the meeting that happened in late January.

On page 72 in our Service Manual, it says "members need access to all information about the issue, they need clarity in what their discussions hope to accomplish, and they trust each others' motives and capabilities. Committee decisions take time, but it is necessary to take time to hear from all members who want to participate so that a group conscience evolves. Each member puts forth his or her ideas, willing to sacrifice them, believing the best outcome will come from the discussion."

I really like those words "the best outcome will come from the discussion." This report will be presented to all the members of BC/Yukon, who choose to attend the upcoming Area events of the Area World Service Committee Meeting (AWSCM) in May and the Assembly in September. All the members voices and feedback will conclude the best outcome, and that is how a group conscience evolves!

I will close with some tidbits from entries in the Forum February 2017 issue. Step two: "Came to Believe...I don't have to have it all figured out in order to make progress"

Tradition two: "By attending business meetings I am better informed of my Group, District, Area and the World Service Conference group conscience. This is an important part of my personal recovery, by supporting these group conscience decisions I have developed a spirit of humility. Concept two: "Truly a lesson in letting go is allowing the administrative and operational authorities to do their work...my part is to keep my part of the street clean"

# Financial Matters for BC/Yukon Area Groups

Tradition Seven: Every group ought to be fully self-supporting, declining outside contributions. Please refer to pages 55 to 59 in "Groups at Work" or "Service Manual" for a complete explanation of this tradition as it relates to member contributions. <a href="https://al-anon.org/for-members/members-resources/manuals-and-guidelines/">https://al-anon.org/for-members-resources/manuals-and-guidelines/</a>

### **Distributing Group Funds:**

**Your Group Meeting:** Rent or electronic meeting platform fee, insurance (if required), literature, Group Representative expenses to attend Assembly in September, local public outreach, Forum subscription, reserve fund (suggest 3 months expenses) and other meeting expenses as per group conscience.

**Your District:** Rent or electronic meeting platform fee, District Representative's expenses to attend AWSCM (and Assembly if possible), local public outreach projects, workshops, Alateen support (if needed), Beginner's meetings (if needed) and other district expenses as required. (See pp 158-160 in *Service Manual*). BC/Yukon Area will pay for DR's travel and hotel expenses to attend AWSCM if Area funds are available and approval is requested in advance, however districts are encouraged to pay these costs if possible. District funds (not Area) pay for District Representatives meals during AWSCM. Districts may also choose to have the District Representative attend Assembly at the district's expense.

**Al-Anon Information Service Office:** Rent for office, part time employee wages, insurance, telephone, office equipment and other expenses. The AIS offices in Vancouver and Victoria also use the office to receive, store and distribute Al-Anon literature to groups in BC/Yukon area. (See pp 66-67 and 108-109 in *Service Manual*)

**BC/Yukon Area**: Assembly and AWSCM expenses, Delegate travel expenses to attend the World Service Conference, expenses related to Officer's & Coordinator's duties, website costs. (See pp 67-68 and 141-148 *Service Manual* for duties of Assembly members)

In a motion passed at Assembly 2007, members <u>suggested</u> a goal of 50 cents per person per meeting be contributed to the Area. Contributions are suggested to be sent 4 times per year – January, April, July, October payable to "BC/Yukon Area Assembly". Mail to BC/Yukon Area Treasurer: **Do not write "Treasurer" or "Al-Anon" on envelope for anonymity reasons.** Complete a contribution form available from the Treasurer or on the BC/Yukon website (member resources page) and enclose with cheque or money order. Be sure to include your group identification number or district # with group name.

**World Service Office:** What WSO does with your contributions - see pp 166-167 in *Service Manual* 

Please keep in mind that the average cost for WSO to provide services to each group is reported by the delegate each year. (2019 it was approximately \$434 Cdn. per group) If sending group funds, your group Treasurer is asked to include the Group's ID Number, Group name and mailing address and GR's name.

### **Literature Coordinator**

Hello everyone,

Is it spring yet? I, for one, am ready for crocuses and daffodils and the feeling of renewal amongst our flora and fauna. It is also a suitable time to brush off the solitude of winter and step out into a world of new possibilities.

Special occasions like Valentine's Day tend to remind us of our losses more than produce warm and fuzzy feelings of love and affection. Attending a meeting is especially helpful in breaking the isolation and the feeling of loneliness. In our Suggested Al-Anon Welcome we read the words "We who live, or have lived, with the problem of alcoholism understand as perhaps few others can. We, too, were lonely and frustrated, but in Al-Anon we discover that no situation is really hopeless, and that it is possible to find contentment, and even happiness, whether the alcoholic is still drinking or not."

Loneliness is a major factor in our fellowship today. Covid 19 has forced many of us to withdraw from the very source that has given us comfort, the ability to leave our situation and seek out solace in the safe space of an Al-Anon meeting. Giving and receiving hugs, meeting for coffee, approaching another member to talk about sponsorship or to offer our service to a group are all aspects of breaking the silence and the isolation of the family disease of alcoholism. Notwithstanding the isolation brought on by another strain of the Covid virus, there are several Al-Anon members are hesitant to admit our need for companionship and socialization and therefore remain isolated and physically apart from other people. It is for times like these that the World Service Office created a Member Blog.

A blog is an opportunity to share with other members. Every month a new topic is introduced. For example, a question is asked, 'What aspects of your recovery are you grateful for?' Members can share their experience, strength, and hope on this topic or write about one of Al-Anon's three Legacies. Any member can share by logging onto the site at *al-anon.org/member-blog*. Sharing's on the Member Blog may be used in future Al-Anon publications.

Another important WSO publication is the Forum. The Forum is the monthly magazine of Al-Anon Family Groups sharing recovery, unity, and service. One section contains an 'instant meeting.' A member shares on a topic like 'Gratitude for the Gifts of Al-Anon' and then encourages the reader to share their own experience, strength, and hope. A year's subscription to the Forum is only \$23 USD (\$29.07 Cdn.) and can be ordered online at *al-anon.org/forum*.

Like all Conference Approved Literature, help is available 24/7. Just pick up any of the many publications, check out the index and 'zoom' into sharing on any topic that interests you and you will find comfort in the words of fellow Al-Anon members who have discovered that 'no situation is really hopeless.' (Suggested Al-Anon Welcome)
