1. Tradition 4 - Each group should be autonomous, except in matters affecting another group or Al-Anon or AA as a whole. Could you be more specific to the word "autonomous"?

Autonomous suggests each group can govern their own meeting. They can choose the time, place, format that suits the members of

that group. However, to be considered an Al-Anon group, each group must follow the Al-Anon Service Manual to ensure that Al-Anon is available in its undiluted form wherever a member may choose to attend. For example: we have Twelve Steps that are not to be changed (copyright), we only use Al-Anon literature in meetings, we do not follow other programs or philosophies while presenting as an Al-Anon group. If the group understands the Traditions and follows them as written, they should not find themselves in a position that will affect another group or Al-Anon as a whole.

2. We have a dual member who wanted to vote for our group at Assembly. When she found out she could not, she asked does this apply just to AA members or other 12-Step programs as well?

On page 152 of the 2022-25 Al-Anon Service Manual, it says a member who is also a member of AA is not eligible to serve as Group Representative. There is no mention of other 12-Step programs.

Members who also attend other 12-Step programs do not have a potential conflict of interest as they are not in any way associated with Al-Anon. While AA is a separate program, we do have a close relationship. Both programs need to guard against the perception of being connected as each program has different goals (Tradition 5).

3. How do I hold a group inventory? What is the suggested procedure?

Guideline G8a provides information on a conducting a Group Inventory. It is available on the World Service website (<u>G8a.pdf (al-anon.org)</u>) or at your closest Al-Anon Literature Distribution Centre.

4. How does one propose a change to the language used in a Step or Tradition? I understand that such changes require approval in writing from 75% of all groups, but is that the final step? What is the first step and the process?

A good start would be to talk to your sponsor. Then bring the topic to a group business meeting for discussion to see if there is unanimity to proceed. If unanimity is found, then ask for a discussion at the District meeting. It is always a good idea to run ideas for change through our links of service first. If members then decide to start a request, the request will need to be sent to the World Service Office at www.al-anon.org and indicate 'Literature Committee' in the subject line. When making your request, provide a full explanation of the reason for the request. When the Committee discusses an item on their agenda, it is done with great care and consideration. It is important to note that a request does not guarantee that a change will happen.

Good day Fellow Al-Anon Members, Since gathering for Assembly in September, I feel like I know everyone so much better!



Ermagarde has been motivated by her Assembly experience, in her role of Group Representative in "Carrying the Envelope" in the links of service between her group, the Area and the Delegate who takes the members of our Areas voices to the World Service Conference. Ermagarde decided to present her report to her group ODAT AFG in the form of a thank you letter.

It goes like this:

To my Dearest friends of ODAT AFG.

I would like to take a moment to thank-you for trusting me to attend Assembly in Langley this year and carry the envelope (your groups voice, votes, and questions for the Area) on your behalf. As well as share some of the information presented.

The Theme of Assembly was Love, Laugh and Grow Together.

Our Assembly Chair, Patty, went over the Assembly Purpose and Goals and "Presume Goodwill".

It was amazing to experience that in action. There was respect and acceptance of each other even with differing thoughts, feelings, and ideas. Although there were some radically opposing opinions, no-one booed, no-one was denied a voice, and everyone was respected.

Some important pieces of information I learned about at the Group Representative Orientation that I think impacts our group meeting format is about the wording of Al-Anon in the Three Legacies. This is explained in our Service Manual in the last section the Charter Appendix #3 IN RELATION TO AL-ANON 3d. No changes are to be made without the written consent of three quarters of the Al-Anon Family Groups worldwide. After listening to the discussion on this at Assembly, I am concerned about how some members of our group decided to and have changed the pronouns and God in our Steps and Traditions. Also, we use the M-59 binder that was issued by World Service Office, but in 2007 this binder was removed from use by the World Service Office. The World Service Office sent a letter to every registered group worldwide and asked them to stop using the binders and replace their meeting format with the newly produced Al-Anon and Alateen Groups at Work P-24/27. A copy of which was provided with that letter. The main reason being that groups were altering the readings/steps/traditions as well as inserting their own groups notes in with the original binder material which alters Conference Approved Literature and violates the copyright. See explanation on World Service Conference Summary 2008 pg. 85.

I know as a group we have a routine and are used to our binder and meeting format, but both these concerns are what they call the "OBEDIENCE TO THE UNENFORCEABLE". Just like Anonymity, they are part of our Traditions. ODAT AFG's unity and perhaps even our group's survival is dependent on adherence to these suggestions.

I ask that the Group consider a discussion and perhaps doing a Group Inventory using guideline 8a and 8b and taking a Group Conscience on using the Al-Anon/Alateen Groups at Work P-24 instead of the Meeting Binder for our meeting format and readings and to not use our member's changed wording version of the steps and traditions in our meeting format. I can use the Group Representative Binder for our group information, contacts, and announcements, but that is not for the meeting format. Everyone can read from Conference Approved Literature - the Al-Anon/Alateen Groups at Work P-24.

I am happy to discuss this prior to taking a group conscience on how to proceed. We could put it on the agenda at our upcoming business meeting.

Judy, our group Alternate Group Representative, and I participated in the discussions, and I voted on our group's behalf as we discussed prior to Assembly.

The summary of business at Assembly can be seen in the Chair Patty's recap of Assembly when it is posted.

Owen, our Delegate, gave a very interesting report on the World Service Conference. He talked about the finances at the World Service Office level. The literature sales are the major source of income, and the rest comes from the groups and individual members contributions. The cost of servicing one group for WSO is \$321.25 US. The Delegate's detailed report will be posted on the BC/Yukon Al-Anon website.

The Literature Coordinator gave a very informative report about Copyright and the use of CAL.

Quick Facts:

- There is a total of 173 registered Al-Anon/Alateen Groups in the BC/Yukon Area
- The groups meeting in person face to face account for 156.
- The registered Permanent Electronic Groups account for 17.

- Participating in voting at Assembly 65 in person and 18 online. Total groups represented in voting at Assembly was 83.
- I did not get the number of total participants at Assembly.

Fellowship Facts:

- We both attended the Early bird Al-Anon meeting and what a buffet of sharing that was!
- We enjoyed a lunch at the hall served with plenty of mingling and Al-Anon discussions from members all over BC.
- We enjoyed two dinner meals, Friday, and Saturday night at public places, but we sat with members from other Districts and shared Al-Anon discussions but from a variety of new perspectives.
- The business on Saturday was followed by an amazing Al-Anon Sunday morning Spiritual meeting with many jewels of the spiritual principles of the program.

Thank you again for providing me with the privilege of being your trusted servant and allowing me this amazing experience.

I encourage you all to consider service in Al-Anon and the rewards that go with it.

I look forward to hearing from many people who want to serve our wonderful program of Al-Anon and expand on their recovery.


